The Management in Practice Programme continues to support College members and their practices as follows:

- ^ Training courses for GPs, practice managers and practice staff.
- ^ Information provision through publications and guidelines.
- ^ Direct advice and consultation with individual members and practices telephone advisory service and online information service/resource via www.icgp.ie/mip.
- ^ Consultancy on site: broad range of management issues including business planning, practice continuity, staff employment, expansion of practice, premises, and health and safety.
- ^ Mediation service: provided both to practice partners and in relation to employees.
- ^ Referral to external professional advisors and resources.
- ^ Supporting the occupational health needs of GPs and practice personnel. (Refer to Health in Practice Programme Report)

NEW INITIATIVES

Certificate in Management in Practice Course through Distance Learning, September 2006 – May 2007

This course has been developed to meet the changing needs of practices. 26 participants, GPs, practice managers and other practice staff, with managerial responsibilities, are enrolled on the course. The course requires considerable commitment from participants. This new course format, which includes formal assessment, meets the training and the management skills needs of participants to a high level. Diploma status and external accreditation of this course is being progressed.

Management in Practice and the General Practice Registrar

Work has commenced on the design and development of a management course tailored to the needs of GP registrars during their fourth year of training. An emphasis will be placed on preparation for establishing in practice after training.

Practice Staff Training Courses

5 practice staff courses were delivered between May 2006 and April, 2007 in Athlone, Cork, Galway and Dublin, 75 participants registered. This course is designed to give practice staff an opportunity to develop their functional roles: receptionist/secretary/administrator and increase their contribution to the practice. Feedback from both GP employers and practice staff alike, remains consistently positive.

HUMAN RESOURCE COMPLIANCE FOR GENERAL PRACTICE SERVICE (HRC)

There has been a very positive response and take up of the service by College members and practices. This further enhances the existing service provided by the programme to GPs in the area of employment regulations. The service provided is on site / in practice support and advice, enabling GPs to become fully compliant with their legal obligations and to improve human resources management in the practice. Other initiatives under consideration include:

- ^ Proposed collaboration with the ROI Faculty of the RCGP on risk management and practice staff.
- ^ GP secretary and administrator course for new or prospective practice staff.
- ^ Reception staff training for external agency.

ONGOING ACTIVITIES

- ^ Development and delivery of practice management course for GP registrars.
- ^ Input for College Summer School programme.
- ^ Ongoing course design and development for certificate in management in practice and practice staff courses.
- ^ GPIT course designed to meet the needs of practice managers and other staff.
- ^ Consideration is being given to the development of a training course on increasing IT uptake and efficiencies for all computer users in the practice clinical and administrative.
- ^ One day seminars.
- ^ A number of one day modules and seminars are planned to update skills and knowledge of practice managers and other practice staff. It is hoped that these will be made available in the near future.




HEALTH IN PRACTICE Report

Health in Practice is a confidential system of healthcare and health information for GPs and their families. It is a 'healthy option' alternative to self diagnosis and self treatment and other informal types of healthcare so often accepted by doctors in the past. The service is both proactive and reactive to members needs in that it provides healthcare for doctors when ill while it also optimises the health of doctors by encouraging good personal health and occupational health and wellbeing. The confidential services of HiPP are also available for GPs family members.

EDUCATIONAL AIMS OF PROGRAMME

Promoting good personal health and healthcare for the medical profession is paramount for good quality professional health. Undergraduate and postgraduate education, continuing education and ongoing access to information on managing health issues in doctors is central to maintaining high standards of personal effectiveness, performance and job satisfaction throughout a medical career. Feedback is actively encouraged from persons who use HiPP and from those who deliver the service. Education in line with a growing international culture which highlights the importance of doctors addressing their own health as patients. Provision of information and coordinating assistance to actively manage the particular health and safety risks associated with working in general practice.

- ^ Provision of education through workshops and presentations for College courses e.g. SCALES and management in practice, and for external institutions e.g. UCD, RCSI.

Many doctors from different countries commented at the International Physician Health Conference in Canada (December 2006) that, in Ireland we are fortunate to have a national structured service – HiPP, as set up by the ICGP. In the coming twelve months we will work to promote the service locally and regionally, for example, encouraging doctors to also contact key regional network professionals for information and advice. NETWORK OF ESTABLISHING GPS

Report

The ICGP undertook a series of regional meetings in 2002/2003 and part of the feedback from these meetings was the particular needs of the younger GP. The 2003 AGM held a symposium on the 'Young GP Principal and GP Assistant'. This was well received and further lobbying by individuals led to a meeting of young GPs held in Tullamore in September 2003. This meeting called for more support for new and establishing GPs by the College. A 'new GP' forum was held at the AGM in 2004.

In September 2004 the first project leader of the Network of Establishing GPs (NEGs), Dr Deirdre Burns was appointed. During the tenure of Dr Burns, the initial needs assessment of establishing GPs was carried out and recommendations were made and submitted to Council. Regional meetings began in several areas of the country on a twice yearly basis. They were found to be an effective medium for organising establishing GPs locally both in terms of information dissemination and networking.

In January 2007, Dr John Ball and Dr Shane McKeogh were appointed as project directors to replace Dr Deirdre Burns.

- ^ To make recommendations as to how these needs could be catered for by the ICGP and to begin implementing recommendations.

PROJECT ACTIVITIES/TASKS DURING PAST 12 MONTHS

Regional Meetings

A Contract – Do I Need One? was the title of the autumn 2006 meetings. Presentations were made to establishing GPs by NEGs Steering Committee members and business and financial resources (e.g. accountant) based around the topic of contract negotiations.

Setting up in Practice – a Personal Perspective is the title of the spring 2007 regional meetings. In these meetings, several newly established GPs agreed to present their personal experiences to their junior colleagues. This covered areas such as getting GMS numbers, setting up in private partnership and joining an established practice.

College Website

Based on the NEGs Annual Report of 2006, it was recognised by the incoming project directors that the NEGs section on the ICGP website was underutilised. Consequently, after meetings between the project directors and the ICGP web manager, it was agreed to update the website to encourage more widespread usage of this valuable resource. In this regard:

- ^ A web designer was engaged to produce a new logo for the NEGs project.
- ^ It was agreed to establish the new logo on the ICGP homepage as a means of accessing the NEGs section directly.
- ^ Access to the discussion board was restructured and streamlined to make it more user-friendly.
- ^ The changes have been advertised to NEGs both by e-mail, national newsletter and will be flagged at the next series of regional meetings.

Handbook

In 2007, several meetings have taken place between the project directors and Dermot Folan, Management in Practice Director. During these meetings, agreement on the format and content of the *Handbook for Establishing GPs* was finalised. Sections agreed in the Handbook will include:

- 3. Traditional Roles & Positions for GPs
- 4. Setting up a New Practice
- 5. Legal and Taxation Definitions for GPs
 - a. Employee

 - e. Partnership Legal Definitions
- 6. State Contracts
- 7. Practice Management
 - a. Information Management Software Systems, Mobile Phone, Laptop
 - b. Administration/Organisation
 - c. Telephone
 - d. Computerisation
 - e. Patient Management
 - f. Time Management
 - g. Advertising Marketing your Services
- 8. Negotiation
- 9. Useful Contacts Booklist, Telephone Numbers etc.

Work on the Handbook is well underway. Resources for each of these chapters have been obtained. This includes research and utilisation of international experience in this regard.

NEGs National Conference

Following review of the 2006 NEGs Annual Report, discussion with the Steering Committee via teleconference, and general consultation with establishing GPs at regional meetings, a desire to organise a National Conference for establishing GPs was identified. In this regard, a detailed proposal was prepared and submitted for consideration to the ICGP Executive.

The project directors along with members of the Steering Committee met with the Executive in February 2007 to discuss this idea. At present, the directors envisage a weekend conference. The conference will be open to all establishing GPs and GP registrars in clinical practice. It will take place in a hotel with conference facilities, probably in the Midlands. The Executive agreed with the proposal and a decision was made to organise the first National NEGs Conference for late 2007 or early 2008.

IMO & IMO Conference Attendance

Two members of the NEGs Steering Committee now sit on the IMO GP Committee. They liaise regularly with the rest of the Steering Committee and the project directors with regard to IMO related matters. Both project directors attended the IMO AGM GP workshops in Killarney on behalf of the ICGP NEGs in April 2007.

Forum Articles

The project directors served as editors for a series of articles published in Forum beginning in April 2007. These articles were originally prepared by GP registrars from the 2006 ICGP Trainee Conference. They deal with the views of GP registrars on their future career options as establishing GPs.

FUTURE PLANS

The Network of Establishing GPs project began in 2004 and is now in its third year. It continues to go from strength to strength. The project plays a crucial role for the establishing GP in that it serves to collate, organise and distribute useful practical knowledge through several media on an ongoing basis. It serves as a signpost in the wilderness for many establishing GPs who find themselves at the most vulnerable time of their careers. By extension, it effectively fosters engagement with the College for the next generation of GPs. Current project plans include:

- ^ Completion of the Handbook for Establishing GPs.
- ^ Forum article updating GPs nationally on the progress of the NEGs project. This will serve to raise the profile of the project and encourage new members to join.
- ^ Further compilation and upgrading of the NEGs database to streamline web-based and paper-based communication nationwide.
- ^ Organising of first National ICGP Establishing GP Conference to further the aims of the project generally and provide establishing GPs from all backgrounds with often their first link with the College.
